This agreement has been mutually concluded according to normative documents named TS EN ISO / IEC 17065 and GLOBALG.A.P IFA ver. 5.2 and/or 5.4 General Regulations.

#### 2- PURPOSE OF THE AGREEMENT

This agreement is made with purpose to determine the responsibilities of EKOINSPEKT and the client, the producers who want to obtain GLOBALG.AP certification by EKOINSPEKT, the control and certification body authorized by the GLOBALG.AP secretariat FoodPLUS GmbH (hereinafter referred to as the "secretariat"), to the producer be controlled accordance with the provisions of the General Regulation of GLOBALG.AP (hereinafter referred to as the "Regulation") and the GLOBALG.AP Control Points and Compliance criteria

## 4. REALISE OF AUDIT, REGISTRATION AND CERTIFICATION SERVICES 4.a REGISTRATION

In order to apply / continue the GLOBALG.AP certification program (hereinafter referred to as "GGBP"), the areas / animals / products declared to EKOİNSPEKT in the application form are submitted by EKOİNSPEKT in the GLOBALG.AP database (http://database.globalgap.org) will be registered within 28 days at the latest.

#### 4.b DOCUMENTS, LEGISLATION AND REGULATIONS TO BE APPLIED

EKOINSPEKT Certification Procedures, GLOBALG.A.P General Regulations in force and GLOBALG.A.P Control Points and Compliance Criteria within the relevant scope published by the secretariat are used. These documents are available on <a href="https://www.globalgap.org/uk">www.globalgap.org/uk</a> en/documents/#.

In addition, if the producer signs this offer and the offer becomes a agreement; EKOINSPEKT is obliged to comply with all provisions specified in its procedures and all criteria determined by the secretariat.

#### 5. CONTROL OF THE PRODUCER / PRODUCTION AREAS

#### 5a- PRODUCER GROUP QMS (QUALITY MANAGEMENT SYSTEM) INSPECTION

It will be inspected by the QMS Checklist of QMS GLOBAL G.A.P established in the Producer Group Headquarters .

#### 5b- CONTROL OF PRODUCER / PRODUCTION AREAS

After planning the inspection / control of the producer or producer group, production areas, product processing areas will be checked at least once a year with the relevant GLOBALG.A.P Checklist. If it is a producer group making an application, a QMS audit will be carried out first at the center of the producer group at least once a year. If the producer didn't have Internal audit before EKOINSPEKT certification audit, the certification audit is stopped by EKOINSPEKT. If harvesting and product are included in the scope of process certification, the harvesting process must be observed for each product group. The GLOBALG.A.P General Rules are followed for the subsequent inspection / controls.

By signing this agreement, the producer accepts and declares that he will unconditionally open his farm, land and other units to the assigned EKOINSPEKT inspection / controller for GLOBALG.A.P control. EKOINSPEKT will control the producer group by the minimum square root of the producer group. If different crops are harvested at the same time, the minimum square root of the number of producers producing each product will be inspected. In the first year inspection of the producer, the harvest will be seen for each product.

#### 6. CERTIFICATION, SUSPENSION, CANCELLATION PROCESS

**Document Name:** 

As a result of the controls, if there are nonconformities that prevent certification, within 28 days after correcting them, GLOBALG.A.P. certificate will be issued whatis valid for 1 year for the product in matter. If these nonconformities are declared by the producer and the producer does not suspend himself until the next control date or if the evidence (report, record, photograph, etc.) is not sent to EKOINSPEKT within 28 (twenty-eight) days that it is closed the producer will be suspended for 6 (six) months at the end of this period. This will not exempt the producer from paying the fee specified in this agreement. If the producer cannot provide the appropriate evidence within 3 months, EKOINSPEKT has to check them on site.

In this case, the producer is invoiced as an extra man / day (500,00 EURO + VAT). At the end of the 6-month period, if the producer still cannot deliver the evidences to EKOİNSPEKT that the non-conformities are corrected and if they do not accept on-site control, the certification process will be cancelled and the producer cannot apply for GLOBALG.A.P certificate again for 12 months following the cancellation date. If the certification process is successful, client information and certificate information will be published in the GLOBALG.A.P database (http://database.globalgap.org) and a 1-year GLOBALG.A.P certificate will be issued to the producer.

#### 7. UNANNOUNCED CONTROLS

- 7.1. In addition to the controls carried out, EKOINSPEKT controls at least;
  - \*%10 of total individual producer number
  - \*%50 of group member number were audited
  - \*%10 of group QMS number
- **7.2.** During unannounced controls; notifies the producer the producer organization or the entrepreneur at least forty-eight hours before the control. The producer, producer organization or entrepreneurs may request a one-time postponement of the unannounced control by providing a valid excuse.
- **7.3.** Which individual producer-producers will be controlled depends on the findings of the initial certification control and feedback-complaints about the client, etc. Producers to be checked without notice are selected randomly.
- **7.4.** By signing this agreement, the client agrees in advance that an unannounced control can be made (48 hours prior notice) and that sanctions may be imposed (suspension-cancellation, etc.) in the event the nonconformity points are determined as a result of this control.
- **7.5.** The client may not accept the unannounced control only once with a documented and justifiable reason. If the same producer does not accept the unannounced control for the second time, it will be directly suspended.
- 7.6. Unannounced checks are included in the annual certification fee.

#### 8. UNANNOUNCED REWARD PROGRAM (It is only valid for IFA ver. 5.2. Standard)

- **8.1.** The producers may choose to participate in the Unannounced Reward Program if the following is true: EKOINSPEKT should inform the producer about this possibility and present the Unannounced Reward Program.
- **8.2.** Under the Unannounced Reward Program, producers will be excluded from an additional 10% unannounced inspection. However, the annual audit will be unannounced by following the same rules explained in Art.7. This could be able to reduce inspection fees of CB.
- **8.3.** Inspections under the Unannounced Reward System will always be carried out using the entire IFA checklist in accordance with the relevant scopes and sub-scopes.
- 8.4. Unannounced Award Program participants are excluded from off-site module audit methods.

- 8.5. Participation in the Unannounced Award Program, gets registered as a feature in the GLOBALG.A.P. database.
- **8.6.** In justified cases (e.g. complaint follow-up), CB's still have the right to schedule unannounced audits during the validity period of the certificate.
- **8.7.** If the producer also needs to be audited for a attachment and the attachment rules do not explicitly include unannounced attachment evaluations, the producer will not be able to participate in the Unannounced Rewards Program.

- activities carried out and keeping the records and information of them available under EKOINSPEKT inspection.
- 10.5. When required, the client allows the participation of EKOINSPEKT, Accreditation Bodies (eg TÜRKAK) and GLOBALG.A.P observers together with the authorized EKOINSPEKT / controller or solely.
- **10.6.** Client can make requests for certification in accordance with the scope of certification.
- 10.7. The following changes that may affect the client's ability to comply with certification requirements (e.g. legal, commercial, organizational status or ownership; organization and management (e.g. key managers, decision makers or technical staff); changes in product or production method; contact address and production locations is responsible for informing EKOINSPEKT about major changes in the quality management system without delay.
- 10.8. The client is responsible for the accuracy of the information given in the "PR24-FR01 Application Form" sent during application and registration step. If this information cannot be verified during the audit, it accepts in advance the incompatibility and sanctions that will arise.

#### 14. AGREEMENT VALIDITY
